





CMS cyber liability and media capability





The cyber agenda is a key areas of focus for European and national policy, resulting in rapidly changing law and regulation. A core focus of data security is privacy and data protection, and the new European Data Protection Regulation, shortly to come into force, will be a 'game changer' for the industry. Corporates will be required to notify data subjects who are subject to a breach of security, and must do so as soon as practicable, and in any event within 48 hours. This issue, as much as any other, is driving the current growth in the cyber insurance market in Europe. In our experience, few clients have the technical or operational systems already in place to comply with this change in law.
